Abuses of Season Pass privileges including misconduct on the ski hill, resale or transfer of the pass, or any tampering or changes to the pass will result in forfeiture of the pass without refund.

There are **NO REFUNDS** due to lack of snow, the length of season, or any other reason.

ASSUMPTION OF THE RISK, RELEASE, AND INDEMNITY AGREEMENT

In consideration for the purchase of a Warner Canyon Season Pass, use of the pass, and Warner Canyon premises, I/We acknowledge that I/we understand that skiing and related activities can be hazardous and, by signing below, I/we have voluntarily accepted and assumed any and all risks of property damage, injury or death resulting in any way from my/our participation in skiing and/or related activities or other use of Warner Canyon Ski premises, including but not limited to, the inherent risks of skiing or negligence on the part of the part of the Fremont Highlanders or any other person or entity.

The undersigned further agrees to release from liability and to indemnify and hold harmless Fremont Highlander Ski Club, Inc. and its officers and directors , owners, employees and volunteers, Warner Canyon Ski Patrol, and Lake County from and all claims (including costs and attorney fees) that I/we may now have or which I/we may hereafter have for property damage, injury or death which I/we may suffer or for which I/we may be liable to others, arising out of or in any way connected with my/our preparation or practice for, or my/our participation in, any ski races, ski training, skiing, snowboarding or any use whatsoever of the premises, facilities or services of Fremont Highlanders Ski Club, Inc. This assumption of the risk, release and indemnity agreement shall apply to all claims based upon negligence and any other theory or recovery, except claims based upon willful or intentional misconduct.

The undersigned understands this document is an express assumption of all risks of skiing, snowboarding and related activities and agreement of release and indemnity which will prevent the undersigned or the undersigned/estate from recovering damages from Fremont Highlanders Ski Club in the event of death or injury to person or property regardless of the case. The undersigned, nevertheless, enter into this agreement freely and voluntarily and agree it is binding on the undersigned and the undersigned's heirs and legal representatives.
